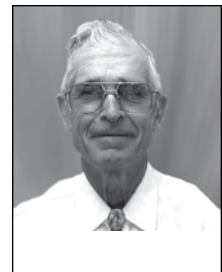

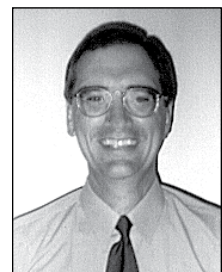

Director Nomination Procedure

This information is found in your By-Laws Of The Twin Valley Electric Cooperative, Inc., on pages 11 and 12 section 4.05. You now can find this online at <http://www.twinvalleyelectric.coop>. You can find the By-Laws under member services.

The Board shall appoint a nominating committee not less than 30 days nor more than 90 days before any meeting of members, at which directors are to be elected. The committee shall consist of not less than five nor more than 13 members who shall be selected from different areas of the cooperative. No member of the board may serve on this committee.

The nominating committee shall prepare and post a list of nominations for directors at the office of the cooperative at least 20 days before the meeting. The Secretary shall mail a statement of the number of directors to be elected and the names and addresses of the candidates nominated by the committee at least 10 days before the date of the meeting.

Nominations may be made from the floor at any meeting of the members at which Directors are to be elected. No member may nominate more than one candidate.

Fifteen or more members acting together may make other nominations by petition. The Secretary shall post the nominations at the same place where the list of nominations made by the committee is posted. Nominations made by petition, which are received at least five days before the meeting shall be included on the official ballot. Later nominations by petition shall be treated as nominations from the floor.
