Daniel Peterson, Mound Valley

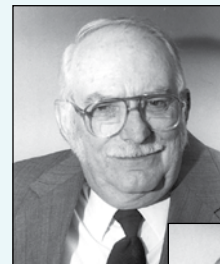
District 3

Any member is eligible to become a Board member of the cooperative provided they are a bona fide resident of the particular district which is open for election and are not in any way employed or financially interested in a compet-

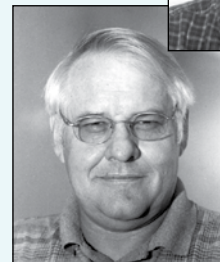
