

Minutes of 75th Annual Meeting of Members

TWIN VALLEY ELECTRIC COOPERATIVE. INC. TUESDAY, APRIL 26, 2022

The 75th Annual Meeting of the Members of Twin Valley Electric Cooperative Inc. was held in the cafeteria on the campus of Labette County High School in Altamont, Kansas, on Tuesday, April 26, 2022.

The meeting was called to order by President Bryan Coover at 6:30 p.m. Trustees, employees, several guests and members were present.

President Bryan Coover welcomed the members and announced that at least 88 members were in attendance.

Secretary Bryan Hucke declared that the notice of the annual meeting was deposited in the mail on March 25, 2022, at the Pewaukee, Wisconsin, post office.

President Coover then called for a motion to approve the minutes of the meeting in 2021 as mailed with the notice of this meeting. A motion was made by Dan Peterson and seconded by Pam Baker to approve the 2021 minutes.

Motion carried.

President Coover introduced our attorney, Clifford Lee, to conduct the election of trustees.

Electric vehicles, advances in wind and solar generation, transmission upgrades, and utility-sized battery storage are not just plans, but happening today.

President's Report

Long anticipated changes to the national electric industry are finally arriving. Electric vehicles, advances in wind and solar generation, transmission upgrades, and utility-sized battery storage are not just plans, they're happening today. The beginning of the transition of historically fossilfueled industries like fertilizer and steel manufacturing to renewable energy are close to reality. Hurried along by federal legislation last year, investments related to renewable energy will continue to increase in our nation's effort to meet ambitious carbon dioxide reduction goals set for the next 25 years.

Much of this change is coming to Kansas and the other Midwest states first. We are all aware of the proliferation of wind generators in the state. This trend will continue and likely accelerate. New transmission line investment is up 175% in the last few years, mostly to support current and future renewable energy additions. Mega-sized solar farms and utilityscale battery storage units are under consideration.

Because of the rising interest in electric automobiles and stationary batteries, several battery manufacturing

facilities are under construction around the country, including one in De Soto, Kansas, by Panasonic. There hasn't been this much activity in the electric utility industry since the Rural Electrification Act in 1936.

But how do these transitions affect this co-op? For some time now, the rural electric cooperatives have been planning in anticipation of these changes. Although electric cars may seem far away, several auto manufactures plan to go all electric in the next few years. With off peak charging schedules, Twin Valley's system should handle vehicle charging well into the future with minimal upgrades.

Interest in rooftop solar has recently grown as well. This can be more of a challenge for Twin Valley, since those systems don't yet include the capacity to store excess generation.

When considering the addition of

either vehicle charging or solar generation, please keep Twin Valley informed of your plans when modifying your service needs.



CEO's Report

Twin Valley Electric's Annual Meeting of the Members will be held on April 20. Registration and dinner will begin at 6 p.m. The meeting will begin at 6:30 p.m. We know you all have busy schedules and limited time, so we make every effort to keep the meeting time under an hour.

The annual meeting is a good opportunity to speak with the cooperative board of directors and the employees, and to get an update on the happenings at your cooperative. If you are unable to attend, I will address many of our key activities in this report.

Weather played a significant role in 2022. Consistently high temperatures from April through October caused us all to use more energy to cool our homes. Increased sales combined with a tight rein on expenses resulted in a healthy margin for the year. Because TVEC is a cooperative owned by its members, those margins are allocated back to you.

Operationally, we continue to replace aging poles and conductor while reducing span length to strengthen our system and improve the reliability of our service. Line clearance continues to be a focus as the majority of the power outages we experience are caused by trees in the lines.

Whether we're constructing new line, restoring power outages, or assisting members in the office, safety is always a priority. Our employees' focus on safety has resulted in another year without a significant injury. I genuinely appreciate our employees' dedication to working safely, as well as their dedication to serving our membership and I hope our members feel the same way.

As our board president noted in his report, the use of evolving technologies such as solar arrays and electric vehicles are becoming more prevalent on our system. You might be surprised to hear that we support their implementation. When implemented properly, both EV's and member solar arrays have benefits to both the member and the cooperative. Conversely, when these technologies are poorly implemented, they can have an adverse effect on TVEC and the rest of our membership. For this reason, we encourage members who are interested in EVs or solar arrays to contact our office to learn more about the proper sizing of solar arrays and proper charging of electric vehicles.

In addition to our attention to the workings of our cooperative, it is necessary that we also pay close attention to what's happening with state and national legislation. Along with our statewide organization, Kansas Electric Cooperatives, Inc., we follow legislation impacting utilities very closely to ensure our cooperative and the members are not adversely impacted. While these efforts have been made for decades, they have never been more important than they are right now. Recently proposed legislation is pushing for change in the energy sector that is not practical, or often possible, at the pace in which the legislation would require. This is a concern for all of us. We will continue to advocate for our membership to ensure they have access to safe, reliable, and affordable energy.

TVEC was formed to provide electricity to our members and improve their quality of life. That is what we still do today. We've not forgotten our mission, and we truly appreciate the support of our membership.
